NOTICE

All the students are hereby, informed that Ragging is Prohibited as per the directions and guidelines of Hon'ble Supreme Court of India, AICTE, New Delhi, University Grants Commission, New Delhi, Dept of Technical & Professional Education Govt. of U.P. vide G.O. 438/16-1-2011-250/96 communicated vide GBTU (now AKTU) Circular No.27216-27829 dt.12-08-2011 & successive circulars No.3058 dt. 19-06-2012 circular No.11581 dated 13-8-2018 circular No.21 dt. 26-06-2023 issued by Dr. APJ, AKTU, Lucknow (formerly GBTU/UPTU) from time to time.

Ragging is also prohibited and punishable under U.P. Prohibition of Ragging in Educational Institutions Act, 2010. Students must download booklet of Anti-Ragging containing guidelines and they are required to submit the Online Anti-Ragging Undertaking of self and that of their parents through given link https://antiragging.in/affidavit registration disclaimer.html, In this regard, the main circulars have also been uploaded over the institute website. These, guidelines also specify various types of punishments to be meted out to the students indulging in ragging or other indisciplinary activities.

Therefore, if any student is found involved or held guilty of ragging and/or abetting ragging, actively or passively or being part of conspiracy to promote ragging in any form, or found involved in any other type of insdisciplinary activities, he/she shall be liable to be penalized depending upon the nature and gravity of the offence, as established. The possible punishments shall be any one or any combination of the following:

- 1. Expulsion from the Institute,
- 2. Suspension from the Institute and academic privileges,
- 3. Suspension/Expulsion from the Hostel, Mess,
- 4. Debarring from Training/Placement process,
- 5. Debarring from appearing in any test/examination or other evaluation process,
- 6. Withholding of results,
- 7. Withdrawal of Scholarship /Bus facility,
- 8. Any other punishment, as deemed fit, by the Institute.
